

Schuylkill Area Community Foundation is a charitable nonprofit organization that works to strengthen and promote charitable giving in Schuylkill County. Each and every resident, business and organization are the Pillars of the Community.

Six primary pillars represent the Schuylkill Area Community Foundation's goal to improve quality of life in Schuylkill County.

Take the challenge to turn your passions into legacies. Whether it is helping children, protecting the environment, enriching the community, you can make a difference by giving through the charitable work of the Community Foundation.

Types of Funds to Consider

Designated

These are created to perpetually benefit one or more specific charities. Grants will be made in the name of the fund so long as the organization remains in operation and is consistent with its original charitable purpose. In the event the designated organization ceases to exist, the Foundation works to identify a similar organization to maintain the spirit of the original charitable intent.

Donor Advised

An attractive alternative to the creation of a private foundation, a donoradvised fund receives a 100 percent tax deduction for the original and any future gifts. The donors have an active hand in their charitable giving by having the right to recommend annually to the Foundation which organizations should be supported by the fund. Grants are then made, in the name of the fund, to favored charities.

Field of Interest

Perfect for donors wishing to support a particular broad charitable cause, such as the arts, education, environment, health and human services, youth or volunteer programs, to name a few.

Scholarships

Scholarships can support students who are graduating from a particular school, attending a particular school, or studying a specific subject. Each scholarship is unique and each is accomplishing the wishes of the original donor. If you value education and want to give others an opportunity to pursue their dreams, you may want to establish a legacy to honor a loved one. Scholarships within the Community Foundation are often a perfect option for these donors.

Unrestricted

Typically created by individuals with broad charitable interests, these funds offer the Schuylkill Area Community Foundation maximum flexibility to respond to the changing needs in the community.

Why Establish a Fund?

The Schuylkill Area Community Foundation offers donors - individuals, families, businesses and nonprofit organizations - the flexibility and expertise needed to help donors determine which type of fund best matches their interests and will achieve their philanthropic goal.

Minimum amount required to establish a fund:

\$3,500 to establish an annual award for a high school graduate

\$5,000 to establish any other fund \$20,000 . . . to establish a scholarship fund

Ways to Give

There are many ways to give through the Community Foundation. Here are some of the most common methods that donors choose:

Cash

Cash is the easiest way to contribute. Donors who make gifts of cash are eligible for a charitable deduction in the year the gift was made.

Appreciated Stock

Stocks may be donated to the Community Foundation as a charitable gift. Donors are eligible for a tax deduction for the fair market value of the stock and can avoid a capital gains tax.

Bequests

A charitable bequest is the most common form of planned giving and it provides important estate tax advantages. Donors will continue their charitable legacies for years to come by including a gift in their will to support the causes or organizations that are important to them. SACF has recommended legal language for all types of charitable bequests.

Retirement Plans and Life Insurance

Donors can use assets held in an individual retirement account (IRA), 401(k), 403(b), or a similar account to start a fund at the Community Foundation at the time of their death. These accounts, while very attractive to defer tax during lifetime, are the most heavily taxed assets in an estate at death.

The purpose of the Fund is to award annual scholarships to qualified Schuylkill County High School seniors planning to further their education. The selection committee's qualifying criteria include:

• Education – Acknowledges the importance of education as a valuable tool for an individual's success. Exemplifies positive use and appreciation of education and plans to utilize educational opportunities in the future.

• Citizenship – Possesses a positive response to being a member of the community. Embraces a sense of community and giving to others in actions and nature.

• Community Participation/Outlook – Exemplifies volunteerism and community involvement in the past and plans of participation in community activities in the future.

New Funds

John Rich Curran Memorial Scholarship Fund

This fund was established to provide annual scholarships to qualifying graduates of Schuylkill County's high schools as students pursue post-secondary education. In order to qualify, students must have had an Individualized Education Program (IEP) in place at the time of their high school graduation, have maintained a B or better average throughout high school, demonstrated a commitment to community service/leadership outside the classroom, and have demonstrable financial need.



Joseph A. Zane, Esq., 1919-2011

Joseph A. Zane was born in Shenandoah, the son of grocery store owners, Joseph and Katherine Alex Zanecosky. Of the six children, he was their only son. After graduating in 1937 from J.W. Cooper High School, he went on to Valley Forge Military Academy where he was the captain of the football, basketball and baseball teams, and was honored as a scholar athlete. He continued to play football at

the University of Pennsylvania where he received his diploma from the Wharton School of Business. He served as an Army Captain at Fort Richardson with the Alaska Defense Command that ended Japan's only western hemisphere military campaign.

In 1949 he was awarded a law degree from Temple University; soon he resided and maintained offices in Shenandoah and later Schuylkill Haven. He had a colorful fifty-year career as a civil litigator and tenacious criminal defense attorney. He enjoyed the challenge, the law, and helping his clients either as a solo practitioner or working with the firm of Zane, Rossi & Conville.

He was a 64 year member of the American Legion Damato Post 792 and former member of the Schuylkill Haven Lions Club. Attorney Zane was a director of the Miners National Bank of Shenandoah and its successor, Heritage Bank. He also served as the first President of the St. Ambrose School PTO.

He was triumphant on the fairways. With powerful long drives he won the Schuylkill Country Club championship, was named the Club's "Golfer of the Year" four times, and scored five aces.

In 1999, despite bleak odds, he refused to allow a devastating medical crisis overcome his sense of humor, zest for life, and charming, but sometimes contrarian and mischievous free spirit. Soon he returned to the golf course, aware that every day was a bonus. One of his proudest moments was to return in 2005 to his beloved Valley Forge and walk onto the football field for induction into the College's Athletic Hall of Fame. Life was still great. It was during this period, he established a fund with the Schuylkill Area Community Foundation which has and continues to benefit various charities and universities.



The Joseph A. Zane Esq. Family Charitable Trust was established at Schuylkill Area Community Foundation (SACF) on December 1, 1999. This donor-advised fund supports local charities. Two months before Mr. Zane's passing, his son J. Robert presented a contribution of \$3,500 to the members of the Schuylkill Haven Island Committee to help further the transformation of the Island Park.

In 2000 he relocated to Providence Place and lived there for ten enjoyable years, always maintaining an interest in his donor-advised fund as well as never missing the happy hours on Friday afternoons while joking with the staff. On October 10, 2011, Joseph Zane, at the age of 91, quietly passed away, after having lived his life to the max, and returned to Shenandoah for the last time.

Wisdom

SACF is known for prudent stewardship and investment practices. The Foundation's strategy emphasizes conservative growth and preservation of assets for grant-making. By pooling funds, the Foundation is able to provide donors with the advantage of diversified investments.

Elwood T. Bracey 1912-2011



Elwood T. Bracey, 99, of Ashland, passed away July 29 in Winter Park, Florida. Born in Ashland, Feb. 3, 1912, he was a son of the late Thomas B. and Clara Scheaffer Bracey.

He was the former owner and pharmacist of Bracey Pharmacy, Ashland, purchasing it from the former Williams Pharmacy in 1933. Mr. Bracey sold the business to Robert and Barbara Nestor in 1984, and Bracey Pharmacy held a grand opening on August 24, 1987 when it moved to its new location at 626 Centre Street in Ashland.

He was a member of Good Shepherd Lutheran Church, the Ashland Area Chamber of Commerce for 40 years and was past president and secretary until 1998, member of Ashland Lodge 294 F&AM for more than 50 years, past member of Ashland Area Industrial Improvement Group, past member of Greater Pottsville Industrial Development Group, involved in the Mother's Memorial **Restoration Project**. Ashland Ambulance Board and the Pennsylvania National Bank Board of Directors. In addition, he was named the Anthracite Mining Volunteer in 1996 and was a volunteer at the Pioneer Tunnel in Ashland.

Mr. Bracey established the Elwood T. Bracey Fund in 1995 to support broad charitable interests, giving the Schuylkill Area Community Foundation's Board of Directors the maximum flexibility to respond to the changing needs in the community.
