Schuylkill Women in Crisis Endowment Fund

"They say it's the little things in life that count. During my stay at SWiC there were many little things that helped me, leaving me overwhelmed by the



kindnesses shown to me; however, I need to say, that the big things in life that change us forever and happen less often, are equally if not more important. The SWiC staff was right next to me through it all. My appreciation goes beyond

words. During the three worst weeks of my life, I couldn't have been in a better place, not even with friends," said a SWIC shelter resident.

This note an example of the gratitude so frequently expressed to Schuylkill Women in Crisis (SWiC) by survivors of domestic and sexual violence who use the services. Experts tell us that the most critical factor in determining how a victim recovers from trauma is the response he or she receives when disclosing the abuse.

Gratitude is also intended for the many donors who make SWiC's services possible. All contributions to the newly-created endowment fund will enable SWiC to continue services, often life-saving, that help victims transform into survivors.

SWiC works as a catalyst in fostering a community-wide response to the problem of domestic and sexual violence that prioritizes victim safety and holds offenders accountable so that the entire community can become partners in ending violence against women and children.

John and Anna Breitigan Memorial Award Fund

John and Anna met in 1942 in St. Clair, PA. John was a native of North Braddock, PA and was stationed at Indiantown Gap. Anna was living in St. Clair. She arrived in the United States from Czechoslovakia when she was six years old. They corresponded during World War II and married in



1945 at Holy Trinity Church in St. Clair. During their 63 years of marriage they resided in Pottsville and raised a family of seven children.

Jennie Breitigan established this fund as a lasting tribute to her beloved parents.

"They remain two of the most important people in my life and the best examples of the kind of person I want to be. I am so proud to be their daughter," Jennie explained.

The awards will be distributed annually to students who are enrolled at the Joseph F. McCloskey School of Nursing and who meet the criteria established by the donor.

Mechanicsville Ladies Auxiliary Award Fund

The fund earnings will be distributed annually as awards to Pottsville Area High School Seniors who meet the criteria established by the donors. A three-person committee comprised of the Principal of Pottsville Area High School, and a teacher and guidance counselor, selected by that Principal, shall make the recommendation of the recipients for approval by the Schuylkill Area Community Foundation's Board of Directors.

The Mechanicsville Ladies Auxiliary is no longer in existence, but its support of the youth will continue forever.


